4) History of the Property :-

As per the oral information and instruction given to me by my client **Jain Social Federation Public Trust through Its trusty Santosh Manakchand Bothra**. I have investigated the title in respect of **Non Agricultural Plot S.No.152/2/158/1 Plot No.1 total area adm. to 32,905.74 Sq.Mr. situated at Nalegaon Tal/Dist- Ahmednagar and within the local limits of Ahmednagar Municipal Corporation.**

That the said documents placed before me are genuine. I have verified tallied and compared these documents from the records of the office of the Sub-Ragistrar for assurance and also from the records of other appropriate authorities.

The links in the title history of last 30 years of chain of title have been properly established. All the transaction have been duly verified from the relevant records of the register, 7/12 extracts, Mutation Entries. I have also perused Index II Register which is made available to me most of the Index II registers where torn conditions and therefore it was not possible to verify the same. I am submitting the Search Report for 30 years 1991 to 2022 as under.

History of Property –S.NO. 152/2

It appears from record that, the above mentioned property S.No.152 was owned by Bala Kesu Agarkar. It appears he was died in Ahmednagar prior to 15 yrs and in that respect application was filed on 27.06.1973 by his legal heirs and names of his legal heirs Dagadu Balajai, Ganpat Balaji and Names of his daughter Sonabai, Bhagu, Dongars, Chabubai Bhausahab Datrang and his wife Umabai Dagadu Agarkar were entered in record of rights and as said M.E No.1909 was passed it was duly certified by revenue authorities.

It appears from record that, the said S.No.152 was subdivided in Dagadu Balaji and Ganpat Balaji and S.No.152/1 area adm to 12.30 Acer R was owned by Ganpat Balaji Agarkar and S.No.152/2 area adm to 4A 20R was owned by Dagadu Balaji Agarkar and as per sub division M.E No.1910 was passed it was duly certified by revenue authorities.

It appears from record that, Dagadu Balaji was died on 15.01.1977 and names of his legal heirs Mohan, Dattatrya, Maruti and one Daughter Bhagubai Sahadu Panmalkar were entered in revenue record M.E No.3546 was passed it was duly certified by revenue authorities.

It appears from record that, Dattatrya Dagadu Agarkar was died on 08.02.1994 and names of his legal heirs Rajendra, Bhausahab, Anil and one Daughter Mira Madhav Dhadge, Hira Dattatrya Agarkar, Nanda Dattatrya Agarkar and wife Yamunabai Dattatrya Agarkar and as Karta of joint family of name of Yamunabai was entered in holder column of said S.No. and M.E No.5617 was passed it was duly certified by revenue authorities.

It appears from record that, Yamunabai Dattatrya Agarkar have given an application to delete the names from other right column and as per said application names of Bhausahab, Ravindra, Mira Madhav Dhadge, Hira Dattatrya Agarkar, Nanda Dattatrya Agarkar were deleted from the revenue record and as per said application .M.E No.5643 was passed it was duly certified by revenue authorities.

It appears from record that, Mohan Dagadu Agarkar, Maruti Dagadu Agarkar, Yamunabai Dattatrya Agarkar and Bhagubai Sahadu Panmalkar as consenting party have sold 1H 84 R land out of S.No.152/2 to Chandraprabha Datrange on 21.03.1994 for the consideration of Rs.72,000/- as per Sale Deed M.E No.5669 was passed it was duly certified by revenue authorities.

It appears from record that, it further appears from record that, Ganpat Balaji Agarkar have given an application to enter the name of his three son in revenue record of S.No.152/1 and as per his application S.No.152 was sub divided and S.No.152/1A area adm to 1H 72R was allotted the share of Bhausahab Ganpat Agarkar. It appears from record that, Bhausahab Ganpat Agarkar, have sold 0H 40 R land out of S.No.152/1A to Bhimraj Bhausahab Datrang on 30.11.1995 for the consideration of Rs.22,000/- as per Sale Deed M.E No.4980 was passed it was duly certified by revenue authorities.

It appears from record that, Rambhau Ganpat Agarkar, have sold 0H 40 R land out of S.No.152/1B to Bhimraj Bhausahab Datrang on 30.11.1995 for the consideration of Rs.22,000/- as per Sale Deed M.E No.4981 was passed it was duly certified by revenue authorities.

It appears from record that, Laxman Ganpat Agarkar, have sold 0H 40 R land out of S.No.152/1C to Bhimraj Bhausahab Datrang on 30.11.1995 for the consideration of Rs.22,000/- as per said sale transaction the S.No.152/1A, 152/1B, 152/1C was again sub divided M.E No.4982 was passed it was duly certified by revenue authorities.

It appears from record that, Bhimraj Bhausahab Datrang, have sold 0H 40 R land out of S.No.152/1B to Rambhau Ganpat Agarkar on 02.09.1996 as per Sale Deed M.E No.6264 was passed it was duly certified by revenue authorities.

It appears from record that, Bhimraj Bhausahab Datrang, have sold 0H 40 R land out of S.No.152/1A to Bhausahab Ganpat Agarkar on 02.09.1996 for the consideration of Rs.22,000/- as per Sale Deed M.E No.6262 was passed it was duly certified by revenue authorities.

It appears from record that, Bhimraj Bhausahab Datrang, have sold 0H 40 R land out of S.No.152/1C to Laxman Ganpat Agarkar on 02.09.1996 for the consideration of Rs.22,000/- as per Sale Deed M.E No.6263 was passed it was duly certified by revenue authorities.

It appears from record that, Kusum, Ramesh Bhausahab Agarkar, Anil Bhausahab Agarkar have sold 1H 72 R land out of S.No.152/1B to Jain Social Federation Public Trust through its trusty Santosh Manakchand Bothra on 22.12.2008 wide Sale Deed No.5886/2008 for the consideration of Rs.27,45,000/- as per Sale Deed M.E No.10162 was passed it was duly certified by revenue authorities.

It appears from record that, Rambhau Ganpat Agarkar, have sold 1H 72 R land out of S.No.152/1B to Jain Social Federation Public Trust through its trusty Santosh Manakchand Bothra on 27.01.2009 wide Sale Deed No.442/2009 for the consideration of Rs.30,25,000/- as per Sale Deed name of purchaser was entered in revenue record.

It appears from record that, Chandraprabha Datranga have sold 1H 72 R land out of S.No.152/2 to Jain Social Federation Public Trust through its trusty Santosh Manakchand Bothra on 15/09/2008 wide Sale Deed No.3349/2008 for the consideration of Rs.41,00,000/- as per Sale Deed name of purchaser was entered in revenue record.

It appears from record that, as per the order of Tahsildar Hissa Form No.12 was prepared as per order Kra/kavi/Jamin/111/2012 Ahmednagar Dtd.14.02.2012 and as per Superintendent land record the correction No.537/2012 Ahmednagar dtd.09.01.2012 the S.No.152 situated as Nalegaon was Corrected and Akar Fod Sheet was prepared as per Application of Laxman Ganpat Agarkar Dtd.01.11.2011 for measurement of land S.No.152 and as per measurement correction was done in land record Hissa Form No.12 and Gat Book was prepared S.No.152 was sub divided and as per sub division S.No.152/1 area adm to 1H 72R was entered in the name of Laxman Ganpat Agarkar and S.No.152/2 area adm to 5H 26R was entered in Jain Social Federation Public Trust through its trusty Santosh Manakchand Bothra and as per said M.E.24484 was passed it was duly certified by revenue authorities.

It appears from record that, S.No.158/1 was purchased by Dhondiba Narayan Sherkar on 09.01.1945 for the consideration of Rs.2,000/- Shivaji Savleram Devtarse as per said Sale Deed M.E No.274 was passed it was duly certified by revenue authorities.

It appears from record that, on 10.08.1948 Hissa Form No.12 was prepared and S.No.158 was corrected and S.No.158/1 area adm to 9A0R + potkharaba 0.04R was entered in the name of Dhondiba Narayan Sherkar and S.No.158/2 area adm to 9A 28R + Kharaba 0.05R was entered in Maruti Savleram Devtarse. And as per the said Hissa Form No.12 M.E No.231 was passed it was duly certified by revenue authorities.

It appears from record that, Dhondiba Narayan Sherkar was died on 22.05.1949 and names of his legal heirs Dattu, Chandrakant, Suryakant and his mother Malanbai were entered in revenue record M.E No.1365 was passed it was duly certified by revenue authorities.

It appears from record that, on 17.12.1971 Dattatrya Dhondiba Sherkar have given application to enter the following name and there Hissa in said S.No. as per said application 0-4-0 Anna share was entered in Dattatrya Dhondiba Sherkar, 0-4-0 Anna share was entered in Chandrakant Dhondiba Sherkar, 0-4-0 Anna share was entered in Suryakant Dhondiba Sherkar, 0-4-0 Anna share was entered in Malanbai Sherkar and as per said M.E No.3136 was passed it was duly certified by revenue authorities.

It appears from record that, Malanbai Dhondiba Sherkar was died on 01.1.1973 and names of his legal heirs Dattatray, Chandrakant, Suryakant and her daughter Manabai Rambhau Fulsounder. The name of sons were entered in holder column and name of daughter entered in other column and as per said entry name M.E No.4291 was passed it was duly certified by revenue authorities.

It appears from record that, Dattatya Dhondiba Sherkar have given an application his mother Malanbai Dhondiba Sherkar was died on 01.01.1973 and the name of Chandrakant, Suryakant and Dattatray be entered in respect of 0-5-4 Anna share in the said S.No.and as per said entry M.E No.4013 was passed it was duly certified by revenue authorities.

It appears from record that, Dattatya Dhondiba Sherkar have given an application his mother Chandrakant Dhondiba Sherkar was died on 07.01.1993 and as he died issueless the name of Chandrakant, Suryakant be entered in respect of 0-8-0 Anna share in the said S.No.and name of Dattatray was deleted as per said entry M.E No.5467 was passed it was duly certified by revenue authorities.

It appears from record that, Dattatya Dhondiba Sherkar was died on 06.03.2001 and names of his legal heirs Sunil, Sanjay, and her daughter Sangita Dattarya Umap, and wife Sushilabai The name of sons were entered in holder column and as per said entry name M.E No.7686 was passed it was duly certified by revenue authorities.

It appears from record that, area adm to 3H 64R + P.K.0H 04R out of S.No.158/1 was purchased by Jain Social Federation Public Trust

through its trusty Santosh Manakchand Bothra on 16.09.2008 for the consideration of Rs.74,70,000/- wide document no.3350/2008 from Suryakant Dhondiba Sherkar and Sunil, Sanjay, Sangita Kishor Anap and Sushila Dattatray Sherkar, and Manabai Rambhau Fulsoundar as per said Sale Deed M.E No.10003 was passed it was duly certified by revenue authorities.

It appears from record that, Jain Social Federation Public Trust through its trusty Santosh Manakchand Bothra have sold 0.22.10 HR Sq.Mtr. to Ahmednagar Municipal Corporation wide Doc No.3872 on 28.09.2020 and as per said sale deed no.19708 was passed it was duly certified by revenue authorities.

It appears from record that, Jain Social Federation Public Trust through its trusty Santosh Manakchand Bothra have applied to the Tahsildar for Granting the notice for converting the land situated village Nelgaon Tal Nagar S.No.152/2 and S.No.158/1 area adm to 38,767.40 Sq.mtr out of total area adm to 89,400 Sq.mtr. for the purpose of Hospital and Medical institute as per the application of said federation Tahsildar have given notice for payment of Non agricultural Tax on 25.05.2019 for payment of Rs.10,09,032/- it appears that the said amount has been paid by the said federation.

It appears from record that, Ahmednagar Municipal Corporation have given the final sanctioned to the layout on 01.10.2020 out ward no.843 and it appears said lay out has been sanctioned and above mention plot is part of said layout.

It appears from record that, as per the order of Tahsildar Kra/kavi/jamin/30/2021/2023 dtd 31.05.2022 as order of converting the said land in non agricultural use and as per said order new 7/12 was prepared and old 7/12 was closed as per said N.A. order S.No.152/2 area adm to 5H 26R, S.No.158/A area adm to 3H 64R + P.K.0.04R S.No.152/2/158/1 open space N.A. area 36.5226 R Sq.Mtr. entered in the name of Jain Social Federation Public Trust through its trusty Santosh Manakchand Bothra S.No.152/2/158/1 DP road NA area 22.1000 R Sqr.Mtr. entered in the name of Ahmednagar Municipal corporation S.No.152/2/158/1 Plot No.1 NA area 329.0574 R Sqr. Mtr.was entered in the name of Jain Social Federation Public Trust through its trusty Santosh Manakchand Bothra.

In the other right column of the S.No.152/2/158/1 Plot No.1 area adm to 329.05.74 R.Sqr. Mtr. there is entry of name of Yashwant Yadav Khisti and Lalchand Mulchand Kothari of Najar Gahan this entry should be deleted by following necessary procedure.

5) SEARCH AND INVESTIGATION :-

I have taken search record of register and documents which is available and other relevant record for last 30 years and paying necessary search fee of Rs.750/- wide below mention chalan.

On the basis of search made by me and documents placed before me I certify that the property referred in schedule is owned and hold by the above mention owners which is free from encumbrances, charges lien and mortgage or any other claim effecting the clear title as on the date.

After applying my mind and on perusing the above mentioned documents i.e.7x12 Extract, Mutation Extract, which is made available to me. I am of the opinion that the **Non Agricultural Plot S.No.152/2/158/1 Plot No.1 total area adm. to 32,905.74 Sq.Mr. situated at Nalegaon Tal/Dist- Ahmednagar and within the local limits of Ahmednagar Municipal Corporation.** which is specifically mentioned in para 2 of the search report is absolutely free from encumbrances is owned by **Jain Social Federation Public Trust through its trusty Santosh Manakchand Bothra.**
